

## **PRIVACY INFORMATION - LAW. 13 D. LGS. 196/2003**

Pursuant to art. 13 D. Lgs. 196/2003 ("Code regarding the protection of personal data", hereinafter TU), regulation that governs the protection of persons and other subjects regarding the processing of personal data, treatment that must be based on the principles of correctness, lawfulness and transparency and the protection of your privacy and your rights, in relation to the personal data that this association will come into possession, we inform you of the following:

- 1. PURPOSES OF DATA STORAGE.** The control of the information is aimed solely at the achievement of the institutional purposes promoted by the association itself within the limits of the statutory provisions and in accordance with the provisions of D.lgs. n. 196/2003.
- 2. HOW DATA WILL BE DEALT WITH.** Personal data storage will be processed by means of the operations or series of operations indicated in art. 4 paragraph 1 letter. a) of the T.U .: collection, registration, organization, storage, consultation, processing, modification, selection, extraction, comparison, use, interconnection, blocking, communication, cancellation and distribution of data. The operations can be carried out with or without the support of electronic or automated tools. The treatment is carried out by the owner and / or by the persons in charge of the treatment.
- 3. PROVISION OF DATA.** The provision of personal data is strictly necessary for the purposes of carrying out the activities referred to in point 1.
- 4. REFUSAL TO PROVIDE DATA.** Any refusal by the interested party to provide personal data in the case referred to in point 3 makes it impossible to carry out the activities referred to in point 1.
- 5. COMMUNICATION OF DATA.** Personal data will be made known to the persons in charge of the processing and may be communicated for the purposes referred to in point 1 to external collaborators and, in general, to all those subjects to whom the communication is necessary for the correct fulfillment of the purposes indicated in point 1 .
- 6. DISCLOSURE OF DATA.** Personal data are not subject to disclosure.
- 7. TRANSFER OF DATA ABROAD.** Personal data may be transferred to countries of the European Union and to third countries with respect to the European Union within the scope of the purposes referred to in point 1.
- 8. RIGHTS OF THE INTERESTED PARTY.** Art. 7 of the T.U. grants the interested party the exercise of specific rights, including that of obtaining from the owner confirmation of the existence or otherwise of their personal data and their making available in an intelligible form; the interested party has the right to know the origin of the data, the purposes and methods of processing, the logic applied to the processing, the identity of the owner and the subjects to whom the data may be communicated; the interested party also has the right to obtain the updating, rectification and integration of data, cancellation, transformation into anonymous form or blocking of data processed in violation of the law; the interested party has the right to object, for legitimate reasons, to the processing of data.
